




With the possibility of each client having immense variation in their needs and needs changing over time, it is important that most segments of this application/website be optional to allow for flexibility. Checklist or drop down selections for desired services would not be required. However, the privacy policy and safety requirements will be mandatory and must be signed and agreed to by all clients and involved parties.

In addition to these user and system needs for this application/website, there could also be an option for further security/monitoring by providing a product similar to Ring and Nest systems. There is potential to market these additional services as a Gold Package option. Cameras, motion sensors, and contact sensors could be an option to add to a personal care package. A family member, friend, or caregiver may want to be able to check in on a client from time to time. For example, make sure they are taking their medication at a certain time, by checking a camera, when a person might not be present. The agency would have the ability to verify that caregivers are showing up during their scheduled time by using the cameras or sensors. Installing these options could bring up privacy issues, so there would need to be a contract/agreement signed with this addition and would carry restrictions on where they were installed.

4. Alternate Persona Comparison

When considering a caregiver persona, communication would differ as far as main target audiences. The focus would more so be on the client and the agency. The scope of focus for the agency is based on job needs and the client focus is based on their personal needs. There may be some more limited communication with the client's friends, family, and community. There may also be communication with the client's doctors, lawyers, teachers, advisors, drivers, or any other additional services that could be required.

Whereas, with the elder persona or client, the communication would mainly be focused on the caregiver, family, friends, and community. Although, depending on the client's abilities, their communication could overlap with some of the caregiver responsibilities mentioned above. They may be able to take care of some of their own needs. The client, however, would rarely communicate with the agency directly, unless something wasn't going to their liking and they were capable of contacting them.
